It is to inform to all the candidates who have been shortlisted for the advertised posts of Gr. II (1)/Technician (1) vide CSIR-CCMB, Advt. No. 01/2021, that the **Trade Test** shall take place from [10.09.2024 to 12.09.2024] & [17.09.2024 to 18.09.2024]. The detailed schedule of the Trade Test is given below:

## **Instructions to the Candidates:**

### **ADMIT CARDS**

1. **Admit cards may be downloaded from the link [https://e-portal.ccmb.res.in/positions/regular/adv1\\_2021/](https://e-portal.ccmb.res.in/positions/regular/adv1_2021/) w.e.f. 22.08.2024 after 04:00 PM. The link is also forwarded to the respective e-mail id's mentioned in the application form of the candidates.**
2. Candidates are required to report to the Supervisor/ Invigilator half-an hour before the commencement of the Trade Test i.e., the reporting time indicated in the Admit Card.
3. The Candidates are required to produce their valid photo Identity proof in original such as PAN Card/Passport/Driving License /Voter Identity card/Aadhar Card/E-Aadhar Card with photograph issued by State or Central Govt. along with the Admit Card otherwise the candidates shall not be permitted to appear for the Trade Test.
4. If there is any mismatch between the name indicated in the admit card and Photo Identity Proof, the candidate will not be allowed to appear for the Trade Test.
5. No Candidate without an Admit card shall be allowed to Trade Test Venue.
6. Any request to the change of time/date/Venue of the Trade Test shall not be entertained under any circumstance.
7. Candidates appearing for more than one post may note that there will be Separate Trade Test in respect of their applied post codes and Separate Admit cards will be issued.

### **TRADE TEST**

8. Every candidate will be required to sign and affix their left hand thumb impression on the photo-bearing attendance sheet against his/her roll number before beginning of the Trade Test.
9. Candidates must abide by further instructions, if any, which may be given to them by the Supervisor/Instructor at the time of test. If any candidate fails to abide by the instructions or indulges in disorderly or improper conduct they will render themselves liable to expulsion from the Test or such other penalty as the Competent Authority, CSIR-CCMB may deem fit.
10. Silence must be observed in the Trade Test Hall.
11. Smoking/chewing tobacco in the Trade Test Hall is strictly prohibited.
12. Candidates are required to maintain discipline and decorum for smooth conduct of the Trade Test.
13. On completion of the Test, the Candidates shall remain seated at their desks and wait until the scripts/Job works are collected and accounted for.
14. Candidates may ensure that they return the Question Paper Booklet/ Answer Booklet/Job Works to the Supervisor/Invigilator before they leave the Venue.
15. In case of any injury during the Trade Test, the CSIR-CCMB will not bear any expenses towards the treatment of the same. However, First Aid facilities will be made available at the time of Trade Test. Candidates attending the Trade Test

shall not be entitled to claim any compensation from CSIR-CCMB, for any injury /loss/mishap that may occur during their Trade Test.

### **OTHER INSTRUCTIONS**

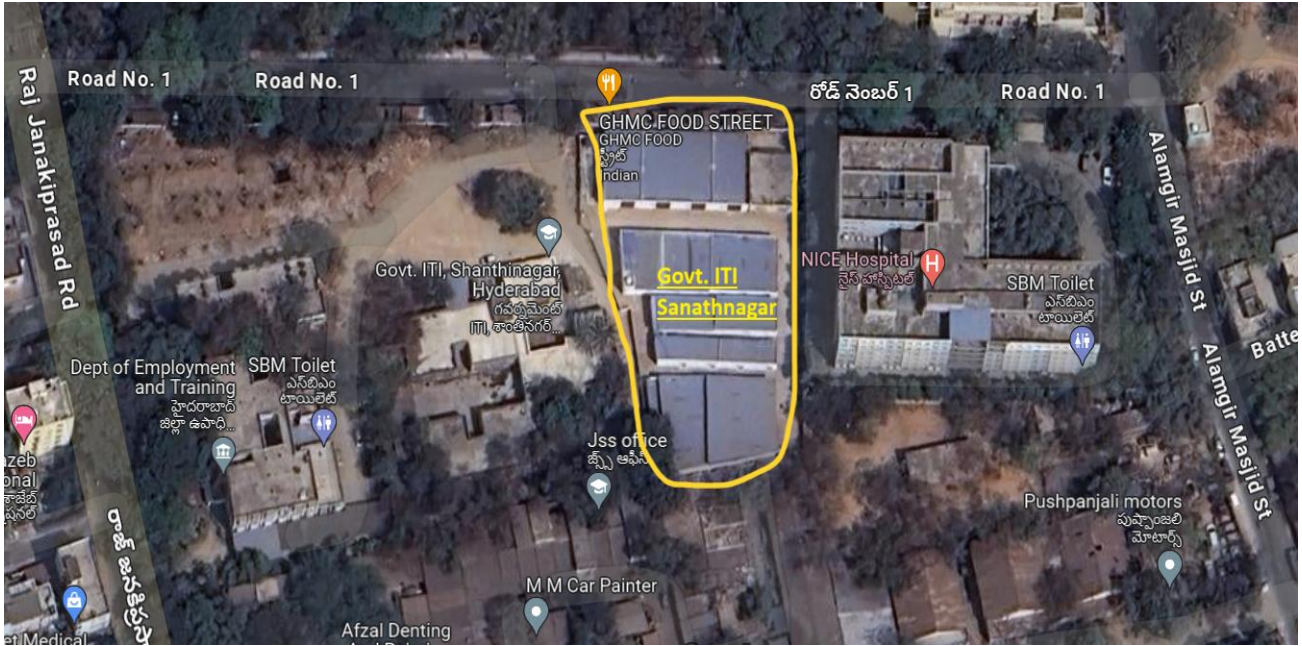
16. No TA/DA shall be paid for attending the Trade Test.
17. Candidates are not allowed to bring any type of electronic gadgets like Mobile phone, Calculator, tabs, laptops, Bluetooth device etc. into the Trade Test Hall and to be deposited at designated place.
18. Persons with Bench Mark Disabilities (PwBD) should contact the Test Venue Supervisor/Invigilator of the venue at least one hour before the start of the exam for assistance in seating, etc.
19. No candidate shall leave the Trade Test Hall without proper permission of the Supervisor/Invigilator and without handing over Answer Sheet/Script to the Supervisor/Invigilator. Candidates failing to deposit the same shall be disqualified and may be liable to suitable action as per rules.
20. The candidature for this Trade Test is Provisional and is subject to fulfilling the prescribed Criteria of Age, Educational Qualifications and other conditions as specified in our advertisement. This admit card is issued purely on the basis of the details furnished by the candidate in the online application form, which is subject to a detailed scrutiny and if at any stage of recruitment any discrepancy found or does not fulfil the eligibility criteria as adopted by the Screening Committee the candidature is liable to be cancelled.
21. The travel and stay arrangements have to be taken care by the candidates themselves. CSIR-CCMB will not bear any expenditure in this regard. Candidates are advised to stay till completion of the Trade Test in case of any delay in completion of the test. Outstation candidates are informed to make necessary arrangements to reach Hyderabad well in advance preferably one day before the Trade Test for their convenience.
22. Any point not covered specifically in the above instructions, the decision of the Competent Authority, CSIR-CCMB, Hyderabad shall be final and binding on all candidates.

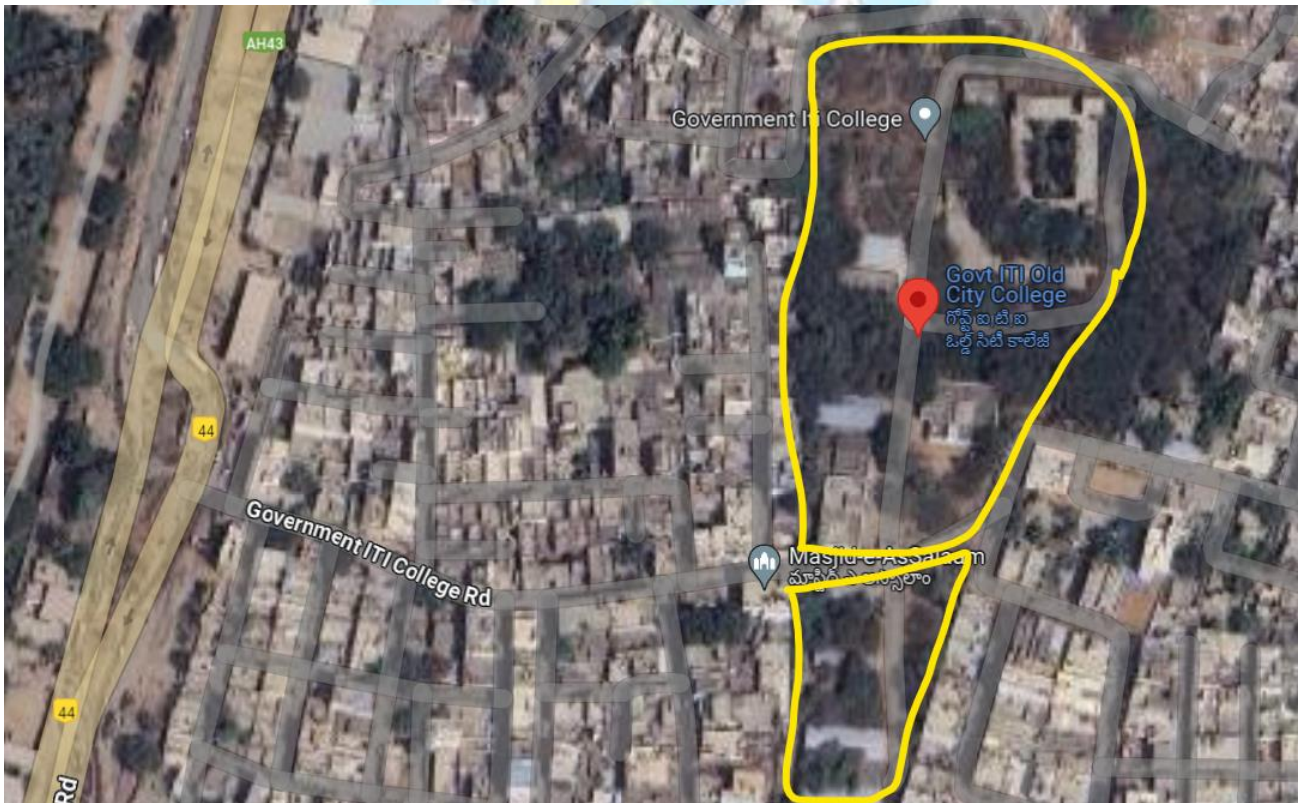
